

## **SJR TRAVEL TOURS GENERAL INFORMATION**

---

**COST:** (see tour specifics for details): All prices are quoted in U.S. dollars. They are based on tariffs, airfares, accommodation rates, and rates of exchange quoted to SJR Travel at the time of publication. These prices are expected to be in effect at the time of departure; however, prices are subject to change without notice. SJR Travel will make every effort to avoid price increases; however, any changes in price made by the airlines, hotels, vendors, operators, etc., with which SJR Travel has made arrangements, may be passed on to the participants. If such rates change prior to departure, SJR Travel is not under any obligation to pay extra expenses arising from unforeseen circumstances, such as a change of itinerary or means of transportation, etc. Extra charges are at the client's expense and will require immediate settlement.

### **REGISTRATION, DEPOSIT, PAYMENT, AND CANCELLATION:**

Early reservations are strongly recommended, and a deposit of \$250 per person is required at the time of booking, with the remaining balance due 100 days prior to departure. The deposit amount may vary by program, depending on the cancellation terms of the airlines and tour operators engaged in providing the necessary services. Applications received within 100 days of departure should include full payment. Any deviations from the group itinerary will require a \$50 service fee, plus the costs of any additional air and land services provided. All checks should be made payable to San Juan Record and personal checks must be received by SJR Travel at least two weeks prior to departure. Within two weeks, a certified check is required for payment. A charge of \$50 will be applied by SJR Travel for all cancellations occurring earlier than 100 days prior to departure. Within 100 days of departure, a cancellation charge of \$200 will be applied by SJR Travel. In addition, any charges assessed by airlines, land operators and other vendors will be added to the cancellation fee. Cancellation fees assessed by SJR Travel, less the value of any materials received, may be applied to a future travel program if that decision is made within 6 months of the cancellation date. The cancellation fees, however, will only be carried forward to a future travel program one time. Late bookings will require a \$50 per person fee (within 14 days from departure), and are subject to approval by SJR Travel and the respective tour director. With the many recent changes in the travel industry such as the issuing of non-refundable group airline tickets, SJR Travel strongly recommends that participants purchase travel protection insurance, particularly where a cruise is included in the itinerary.

**HEALTH:** We advise each participant to have a physical checkup before registering for the program. SJR Travel cannot be responsible for illnesses that may occur while traveling. Since group sight-seeing can be physically taxing, we recommend that persons who suffer from heart disease, high blood pressure, or any physical impairment which could hinder them from normal participation contact SJR Travel prior to submitting an application.

**INSURANCE:** SJR Travel is not responsible for any injury to your person. Further detailed information on insurance coverage will be provided in a separate mailing. Participants will receive information on coverage available for protection against unforeseen circumstances which may necessitate trip interruption or cancellation. SJR Travel is not responsible for any loss, theft, or damage to your belongings. Information on baggage insurance will be sent to participants. Baggage and cancellation insurance is recommended and is available at nominal rates through private insurance companies.

**TRAVEL DOCUMENTS:** Participants must carry a valid passport. You will be provided with information concerning passports and/or tourist cards, visas, and immunizations where needed, but obtaining them is the responsibility of the applicant. SJR Travel will obtain visas for the group.

**ACCOMMODATIONS:** We seek to provide well-located accommodations (not always in the center of the city) representative of the area, which provide typical cuisine; clean, pleasant rooms with private bathrooms; friendly service; and efficient management. The class of hotel, etc., is consistent with the price category of the program; i.e., deluxe and first-class programs stay in first-class accommodations and economy programs stay in lower-class accommodations.

**ROOMMATES:** Single people may sign up for accommodations on a share basis and will be assigned roommates if circumstances permit. If a roommate is unavailable, the participant will be notified of the adjusted price (single supplement) prior to departure.

**ITEMS NOT INCLUDED:** Items of a personal nature, such as excess baggage or portage charges; personal, trip, or baggage insurance; room service; laundry; phone calls; bottled drinking water; food or beverages not part of the group menu; gratuities for special services; passports; immunizations fees; visas; etc.

**NOTICE:** SJR Travel reserves the right to make changes or substitutions in the interest of the program in order to meet unexpected situations, such as increases in fares and accommodation rates, airline failures, changes in currency rates, etc., prior to departure. Additional charges or refunds will be made to participants where applicable. However, no refund will be made for accommodations or services, included in the price, which are not utilized during the program by the participant.

We reserve the right to cancel the program, if deemed necessary, for reasons including insufficient program participation and circumstances beyond the control of SJR Travel. These include events such as strikes, lockouts, riots, wars, and natural disasters. In such an event, SJR Travel shall have no responsibility beyond the refund of deposits and monies paid to SJR Travel by the participants. A refund will then be made to participants within 30 days by means of a bank check.

### **RESPONSIBILITY AND LIABILITY:**

This program is under the management of the San Juan Record, PO Box 879, Monticello, UT 84535. They have made all arrangements for accommodations and services furnished in connection with this program. While on this program, SJR Travel, as the principal, shall be responsible to the participant for supplying the services and accommodations offered to the participant as set forth in the program literature, except to the extent such services or accommodations cannot be supplied, due to delays or other such causes beyond the control of SJR Travel. In such event, SJR Travel will use its best efforts to supply comparable services and accommodations, but provide no refund. SJR Travel, in the absence of negligence on their part, shall not be responsible for any delay, substitution of equipment, or any act of omission whatsoever by the air carrier or by any hotel, guesthouse, car supplier, or any of their employees or agents—or any of the services and accommodations to participants, including any results thereof, such as a change in services or accommodations necessitated by the same. SJR Travel shall not be liable for any death, or for any damages or claims arising from negligence of any person not its employee or under its exclusive control.

**CULTURAL ADAPTATION:** We strongly encourage the participants to realize they are often in a very different culture and environment. We hope you would offer empathy, understanding, and appreciation for the differences and enjoy the experience.

**STANDARDS:** All participants are required to maintain high standards of honor, integrity, and morality; graciousness in personal behavior; application of Christian ideals in everyday living; abstinence from narcotics and alcohol is mandatory.

**ACCEPTANCE:** We do not discriminate on the basis of race, creed, gender, color, or ethnic or national origin.
